## IN MEMORIAM JOSEPHINE F. THOMPSON 1911 - 1988

This issue of the Alumni Newsletter is dedicated to the memory of Mrs. Josephine F. Thompson in recognition of her commitment to high standards of library science training, her enduring support of the School of Library and Information Studies, and her contributions to the education and continuing development of more than 1500 librarians.

Mrs. Josephine F. Thompson, retired professor of the School of Library and Information Studies passed July 25, 1988 at Southwest Community Hospital in Atlanta. Graveside rites were held in Lynchburg, Virginia.

Prior to coming to Atlanta University, Mrs. Thompson worked as an elementary school teacher in Virginia, with the YWCA in Tennessee, and as a researcher for the Atlanta Urban League. Mrs. Thompson joined the faculty, which was then composed of three teachers (Mrs. Virginia Lacy Jones, Mrs. Hallie B. Brooks, and Mrs. Annette H. Phinazee), in 1947 as an Instructor, and retired in 1976 with the rank of Professor. During her 29 year tenure at the library school she taught Research Methods, Libraries and Librarianship, Literature of Science and Technology, Collection Development, Academic Librarianship, Literature of the Social Sciences and other courses offered in the curriculum. In 1971, Mrs. Thompson received the Atlanta University Trustees' Award of \$1,000.00 for "Excellence in Teaching."

She is survived by her husband, Robert Thompson, daughter and son-in-law, Attorney William G. and Sylvia Robinson, of Norfolk Virginia, sister, Mrs. Murriel K. Ware of Pasedena, California, and four grandchildren.

In her classes, Mrs. Thompson's legacy included the correction of papers with the infamous instruction, "Revise and Return." The repeated return of assignments prompted one class to donate her a stamp reading that phrase. In announcing the passing of Mrs. Thompson at the Beta Phi Mu sponsored Hallie B. Brooks Lecture Series on July 27, 1988, Casper L. Jordan noted that our beloved Mrs. Thompson was "Revised and Returned."

Mrs. Thompson's family has asked that friends, colleagues and alumni contribute to the Josephine F. Thompson Memorial Fund, which was established by the Thompson family at Atlanta University School of Library and Information Studies.

### DR. ELIZA GLEASON VISITS ATLANTA UNIVERSITY

Dr. Eliza Atkins Gleason, the first Dean of the Atlanta University School of Library and Information Studies, visited the University campus on Wednesday, June 1, 1988. Dr. Gleason was accompanied by her husband, Dr. Maurice Gleason, a retired obstetrician and gynecologist in Chicago, Illinois and her niece, Dr. Anna H. Simpkins, a Professor of Clothing and Textiles at North Carolina A&T University in Greensboro, North Carolina.

The Gleasons were greeted at the Robert W. Woodruff Library of the Atlanta University Center by Dr. Charles W. Meredith, Chancellor and Dr. Prince E. Rivers, Provost of the Center; Dr. Guy C. Craft, Library Director; and Dr. Lorene B. Brown, Dean of the School of Library and Information Studies. During a tour of the University Library, Dr. Gleason met members of the library staff, including a number of Atlanta University SLIS alumni. Following lunch at Paschal's, hosted by Dean Brown, Dr. Gleason visited the Library School offices and classrooms in Trevor Arnett Hall for the first time since she resigned as Dean in 1946.

Dr. Gleason is a Phi Beta Kappa graduate of Fisk University, and earned a Bachelor of Science degree from the Library School of the University of Illinois and a Master of Arts in Library Science from the University of California at Berkeley. She holds a special place in the history of library science education, as the first Black person to receive the Doctorate in Library Science in the United States. When the School of Library Service was opened at Atlanta University in September, 1941, Dr. Gleason guided the design of the program and its mission. During the School's third year of operation, she directed the successful accreditation of the Library School by the American Library Association's Board of Education for Librarianship.

After leaving Atlanta University, Dr. Gleason continued her distinguished and varied career in Chicago, Illinois as both a practicing librarian at Wilson Jr. College, Chicago Teachers College and John Crerar Library; and as a library science educator at Illinois Teachers College and Illinois Institute of Technology. She has also continued to be active in professional associations and community activities, including serving as Executive Director of the Chicago Black United Fund and a member of the Chicago Public Library Board.



# A WORD FROM THE DEAN

Atlanta University has been awarded a \$2.5 million grant from the Office of Education for the 1988-89 fiscal year. This award must be matched dollar-for-dollar from private funds. This award will directly benefit the University's budget to a total of \$5 million dollars.

The School of Library and Information Studies is budgeted for approximately \$200,000 of this grant for the 1988-89 academic year. We need to raise \$100,000 in order to spend our share of the award. Included in this budget are library resources; media software and hardware; computer hardware and software; renovations of the stack area (storage for the newly acquired collection from Emory and a cataloging laboratory), faculty development and student assistantships.

This award represents a challenge for all of us to assist the Library in implementing its objectives and maintaining its accreditation status. Your support of the Library School in one of its most critical periods in history will insure the continuation of a quality library school. Your contributions, however small, will assist us in this important activity. I do appreciate all of the support that you have given us in the past and for your future assistance.

#### DAVIS, DIRECTOR OF CCLC PASSES

#### HILLIS D. DAVIS 1932 - 1988

Hillis D. Davis, Sr., Director of the Cooperative College Library Center in Atlanta, Georgia passed on Sunday, January 31, 1988. Mr. Davis was a graduate of Johnson C. Smith University, and a 1961 alumnus of the School of Library and Information Studies. During his professional career, Mr. Davis contributed greatly to the development of library services at a number of the historically black colleges and universities. He served as reference librarian and head of cataloging at West Virginia State University and as Director of the Library at Hampton Institute.

Mr. Davis served as the first Director of the Cooperative College Library Center from 1969 to 1988. The Center was established with a grant from the Carnegie Corporation of New York to the National Council of Churches and the United Board for College Development, to provide joint purchasing and technical processing of library materials. The initial membership in the Center included Miles, Talladega, and Tougaloo Colleges and Tuskegee Institute. Under the leadership of Hillis Davis, today membership in the Center has grown to number 31 colleges and universities across the Southeast.

His professional affiliations included the American Library Association and the South Eastern Library Association, which he served as President.

## **FACULTY NEWS**

Dean Lorene B. Brown spoke at the American Association of Law Libraries Annual Conference held in Atlanta in June. She appeard on a panel addressing the topic, "Affirmative Action/Equal Opportunity Employer/Minorities and Women are encouraged to Apply." The Dean also gave a presentation on "minority concerns" for the Junior Members Round Table meeting at the ALA Conference in New Orleans. She has been appointed to serve a four year term as a Presidential nominee to the Massachusetts Institute of Technology Libraries Visiting Committee and the Library Visiting Board of South Carolina State College. She is a member of the Advisory Board for the Office of Library Personnel Resources (OLPR) of ALA. Dean Brown also successfully wrote another grant for \$8,000 in fellowship funds from the Office of Education Title II-B program, and assisted in writing the Title III proposal that awarded \$5 million to the University. She also hosted the Association for College and Research Libraries and the Mellon Foundation, Conference on Historically Black College and University Libraries in October.

Yvonne Chandler Melvin ('79) is a new faculty addition as Assistant to the Dean for Special Projects. Ms. Chandler Melvin is studying toward the Ph.D. in Library Science at the University of Michigan. Her interests include special librarianship and law librarianship.

Her interests include archival administration, and formerly she served as an archivist for the Carter Presidential Library in Atlanta.
