

CHURCHWELL HONORED



The Second Alumni-in-Residence Program, held April 14-15, 1986, focused on the Science and Research Library and the library education accreditation process. Dr. Charles D. Churchwell, Dean of Library Services at Washington University, St. Louis, MO was honored as the Second Alumnus-in-Residence. The two-day program included a panel discussion on careers in Science Librarianship and a public forum. At the public forum, Dr. Churchwell spoke on the subject "Academic Research Libraries: Information Centers of Unlimited Impossibilities".

The honoree, Dr. Churchwell, a 1953 alumnus, is well-known in the library science profession for his accomplishments. He was awarded his doctoral degree in 1966 from the University of Illinois; he was the first Black male and the first graduate of the Atlanta University School of Library Service to earn

a Ph.D. degree in library service. In 1974 Dr. Churchwell was one of six persons that was recommended by the American Library Association to the President of the United States for the position of Librarian of Congress. He has served on several committees in the American Library Association, including the Chairman of the Committee on Accreditation, and the Association of Research Libraries. Dr. Churchwell has published several articles during his career.

The Alumni-in-Residence program was again planned and coordinated by Dr. Penelope L. Bullock, Chairperson of the Colloquium Committee. The School of Library and Information Studies would like to thank each of you who came and participated in this program. DR. BULLOCK RETIRES

Dr. Penelope L. Bullock (B.L.S. '43, M.A. '44) will retire from the School of Library and Information Studies after fifteen years. She joined the faculty in 1971 as an Associate Professor after receiving her Ph.D. degree from the University of Michigan. Dr. Bullock was promoted to Full Professor in 1979. Her primary teaching responsibilities included Introduction to Information Resources (Reference and Bibliography), Literature of the Social Sciences, Afro-American Bibliography, Archival Management, and Government Publications.

In 1981 she published *The Afro-American Periodical Press*, 1838-1909. This book was expanded from her doctoral dissertation.

Dr. Bullock was honored by The Library Science Alumni Society and the School of Library Science of the University of Michigan at the 1986 ALA Summer Conference in New York, as one of eight persons receiving the Alumni Recognition Award, an award "given to graduates who have earned high professional distinction during their careers in Librarianship."

Her leaving Atlanta University signifies more than her retirement; Dr. Bullock is the last of the B. F. Bullock Family at Atlanta University Center since 1932. Congratulations and Best Wishes, Dr. Bullock. We will miss you!

FACULTY NEWS

Dean Lorene B. Brown participated in the Minority Deans Panel Discussion held at the ALA Midwinter Convention. Her presentation based on statistics from authoritative studies concerned the decrease of minorities in the library profession. She served as a consultant at the "Information Access in Historically Black Colleges and Universities" workshop held at Fisk University on April 21-22 under the auspices of the Council on Learning Resources. Dean Brown participated in the colloquium on "Scholars in Librarianship: Professional Models in an Age of Information" held at Jackson State University.

Dr. Joseph W. Coffman will participate in the *Institute on Research Libraries for Library and Information Science Faculty* for three weeks in August on the campus of Massachusetts Institute of Technology and Simmons School of Library and Information Science. He will report on his study of libraries' management and operations of Emory University Libraries.

Dr. Stephen E. James has been selected to serve on the Editorial Advisory Board for *Library Waves*, a professional journal in Nigeria. His article on public library use was accepted by *Public Library Quarter*ly; it is scheduled for publication in 1987.

The Atlanta University Senate and Academic Council granted permission for the lounge to be redecorated and named.
