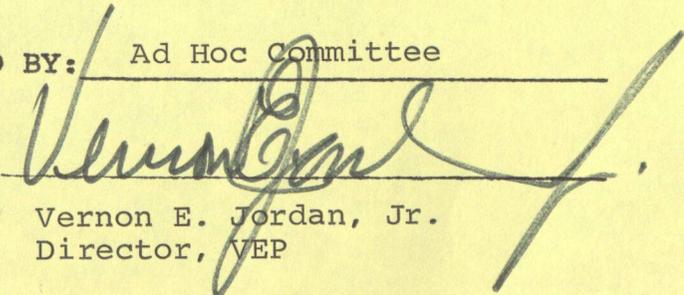

Dear Mr. Olive:

Want to thank you and Mr. Jordan for the two recent deposits to our account. On June 25, I received the deposit slip for the \$240.00, the additional grant for a Chairman's salary. Want to explain (see the enclosed report) why for this week and last week you will see two checks for \$40.00 each time.

The day after I saw Mr. Jordan in Atlanta, we had an organization meeting to elect a new chairman. Two Negro boys, Tasso Thomas and Douglas Lewis, who had both been working with Voter Registration, wanted the post. Tasso is good at ideas and Doug at detail work, and we needed Doug with us all the time because he is a licensed driver. It came to the point that if they weren't getting paid, they would have to quit working with us. And \$20.00 a week didn't seem like enough for one person. So, I took a wild guess and said we'd pay them both \$40.00 a week for the remaining six weeks. According to the way our budget is working out, we should have plenty of money with the additional \$240.00. Hope this is O. K.

Checking with the bank, I discovered the renewal of the grant (your second payment) was for \$190.00 instead of \$200. This is fine, but I noticed it coincided with the amount of my first three checks, \$190. Does this mean that if we don't spend the current part of the grant, whatever is left over is subtracted from the next grant? Please let me know, since we're counting on the full \$1000.00. Incidentally, next week is our big week. Have radio announcements and announcements at the churches this Sunday that we'll be operating all week.
