STUDENTS REACT TO BOARD'S SELECTION OF 11TH PRESIDENT

Social media exploded just after 10 A.M. on Monday morning as the Board of Trustees led by Chairman Robert Davidson announced the selection of Executive Director of the White House Initiative on Historically Black Colleges and Universites (HBCUs) Dr. John Silvanus Wilson Jr. '79 as the 11th President of Morehouse College.

"Pleasantly surprised John Wilson will be able to assume the presidency so soon," junior Anthony Simonton said following the announcement that spread like wildfire on Twitter.

Though many were pleased with Wilson's fundraising prowess as associate provost at the Massachusetts Institute of Technology and as an Obama appointee, others expressed their discomfort with the deviation from the 2007 Presidential Search in which the final three candidates – Wilson, Franklin, and Dr. Calvin Butts – were all invited to meet with students before a final selection was made.

"Why didn't we get to meet him before he was selected," one student tweeted.

have some transparency in choosing its leadership," Associate Professor at City University of New York and Morehouse alumnus Dr. L'Heureux Lewis said.

The announcement hit social media networks just after the decision was announced to faculty and alumni via email.

"The Morehouse College Board of Trustees today announced that Dr. John Silvanus Wilson Jr. has been named the College's 11th president," the press release said. "The appointment follows a rigorous, nationwide search conducted with professional recruitment firm Heidrick & Struggles."

"Dr. Wilson has the vision, experience and passion to ensure that Morehouse continues to advance its aim of producing global leaders who will continue to make a difference in the world," Chairman Davidson also said in the statement.

Wilson was selected to lead the college after having worked alongside The White House, 32 federal agencies and private agencies to increase the capital of HBCUs nationwide.

"I wish John the best as he takes on this important new role as the president of Morehouse College and as he continues to inspire more of our nation's youth to pursue higher education," President Obama said in the statement.

In 2007, the Morehouse Board of Trustees declared Rev. Dr. Robert Michael Franklin Jr. '75 the 10th president of Morehouse College. Having given the college five and a half years of dedicated, committed service, he has decided to return to his true passion, teaching.

There were many students, faculty, staff and alumni in attendance to give their thanks and appreciation to Dr. Franklin this past Sunday at his final address to the College. His mother and family were also in attendance. The service was occupied with songs, dance, litanies, and memories that will last a lifetime.

Franklin was honored with an oil painting that depicts the initiatives that he has implemented and task that he has completed during his tenure.

First Lady Dr. Cheryl Franklin was also honored with a beautiful oil portrait that will grace the Hall of Fame in the Martin Luther King Jr. International Chapel along with other heroic civil rights leaders. She was honored for her commitment to the College, and for giving over \$400k endowment to the college to support students who plan on pursuing a medical career.

"He is a very intelligent man and would always challenge me to grow as an individual," Brooks commended. "We would always have conversations about Plato, Martin Luther King Jr., Aristotle and even the orating style of Otis Moss Jr."

No formal student forum was scheduled or announced by the Senior Trustee Mr. Djobrevic or Ex-officio Trustee SGA President Anre Washington in advance of these meetings. It should be noted that President Washington addressed concerns regarding the college's fiscal challenges and its impact on students in an open letter to the student body which can be found at www.morehousesga.info.



WORLD & LOCAL GA LEGISLATORS, MILITARY LEADERS MEET TO DISCUSS SEQUESTRATION

As congressional members and military leaders gathered across the Monday to commemorate Veteran's Day, Georgia lawmakers and military leaders convened a telephone press conference to discuss sequestration and its

impact on the military and civilians in Georgia.

Sequestrations, from the Latin root sequestrate means "to render for safekeeping." In terms of the economy, sequestration is a term related to the inability of Congress to pass a budget in order to avoid a fiscal cliff. That cliff, set to be enacted on January 1, 2013, would trigger nearly \$500 billion in automatic cuts to the military and other programs.

Democratic State Rep. Gloria Frazier, one of the law-

makers present on the telephone press conference, believes some agencies and programs should be exempt from austerity measures.

"Some stirred by the clamoring defense contractors are calling for the Pentagon to be exempt from fiscal discipline," Rep. Frazier said. "With that, of course, would mean even deeper cuts in Georgia to the programs, jobs, and services we need for a healthy economy."

As recently as August, U.S. Senators Johnny Isakson and Saxby Chambliss toured the state, along with state congressional members to explain the impact of a potential sequester on civilians and military installations.

"Few here in Georgia doubt that our state would feel a significant impact, not only on installations directly, but on the businesses that support them as well," Major General David Bockel, the Executive Director of the Georgia Military Affairs Coordinating Committee said in response to the tour. Civilian and military leaders present on the call also offered solutions to the Pentagon in order to avoid the fiscal cliff, while providing more cost-effective national defense strategies. Heather Hurlburt who currently serves as the Executive Director of the National Security Network has used her expertise of U.S. foreign policy and counter-terrorism as a vehicle for impacting defense policies at the national level. On the call, Hurlburt stressed the importance veterans to the overall economy.

"The number one thing our veterans need are jobs," Hurlburt said. "And there have been studies by the University of Massachusetts that point out that in fact when you cut other parts of the federal budget, you actually cut dramatically more jobs than you do through the pentagon."

A recent poll by the Aerospace Industries Association conducted before the election showed that 80 percent of likely voters want action on sequestration.

Nearly a week after the reelection of President Barack Obama, talks have increased in Washington to start fixing the fiscal crisis. Obama recently invited leaders to the White House to discuss the budget challenges.

"This is an opportunity for the president to lead," Speaker of the House Rep. John Boehner said. "This is his moment to work on a solution that can pass both chambers."

SPORTS REPORTING STUDENTS ATTEND EMORY UNIVERSITY

Students from Morehouse's Sports Reporting class traveled to Emory University's Robert W. Woodruff Library to visit the school's African American Sports collection on Saturday morning - the first class in America to do so.

The host of students were led on the day by Dr. Pellom McDaniels III, a liberal arts professor and curator in Emory's Manuscript, Archives and Rare Book Library.

McDaniels, a former defensive end for the Kansas City Chiefs and Atlanta Falcons introduced students to an exclusive collection of photographs and former syndications, made only available at Emory's Library.

They included photographs of Althea Gibson and Alice Goodman, the first African American woman to win the Wimbledon and US Open Cups, and the first African American woman to win an Olympic gold medal in the 1948 Olympic high jump, respectively. They also included syndications like NAACP's "The Crisis Magazine" and the now defunct magazine, "Our World." that the state of the black athlete is one rooted in rich history and social strife. He spoke of star athletes, Jackie Robinson and Paul Robeson and their political struggles extensively.

While both men differed in political ideology, they proved that the plight of the black athlete extended not only to the athletic realm, but to a political one.

"At that time being political was a problem for black athletes," McDaniels said.

Robeson, a staunch political activist for his time, knew of the danger associated with being black and political all too well. His advocacy of anti imperialist regimes and close association with the communist paradigm led to retribution and public sneer. In 1968, he was denied a visa and lost privilege to travel outside of the United States for failure to recant his political ideals.

Today, while not as extreme, black athletes experience indignations of their own. This extends to their portrayal in popular media.

"It is not that smart athletes do not exist - it is that they're not shown," McDaniels said. "We don't see the black athletes who wash their own cars to save money after pracThis is the inspiration behind his collection at Emory - to educate people about the cultural and social influences of former black, athletic greats. The former Oregon State Beaver is confident it will help change the perception of black athletes, young and old.

This sentiment extends to the current state of black, student athletes.

"It is proven that students with college degrees stay in the league twice as long," McDaniels said. "The system is broken because we've forgot the virtue of being a student athlete."

Athletes like Jim Brown, a 9 time Pro Bowler and the founder of the Industrial Urban League, a company that provides black athletes with financial advisement and business plans, prove that balance for a black athlete is attainable. Over the years, balance is a word that has come to define McDaniels. After an All Pac10 career at Oregon State, McDaniels applied to graduate school, interviewed with State Farm and Proctor and Gamble, and worked out for the NFL all in the same off season.

Though he never boasted about his array of accom-

tice because that's not going to sell ratings."

Rather, it is the ostentatious displays of wealth, and mismanagement of funds that have come to define, and in many ways trap the modern day black athlete. According to McDaniels, who shared locker rooms with NFL greats Marcus Allen and Derrick Thomas, these images are not representative of the true black athlete. plishments, he reserved a subtle confidence. "Put me on the field, and I'll play like a starter," McDaniels said.

He reserves the same confidence for his collection at Emory. "This is a collection that I am going to make the best in the nation," he said.

Anyone who's listened to McDaniels speak for more than ten minutes knows that it will be.

THE PULITZER BEAT U.S. ELECTIONS REMIND KENYANS OF THEIR OWN POLITICAL STRIFE

Citizens of Kenya, the birthplace of President Barack Obama's father, watched closely as Obama was re-elected for a second term as United States President last Tuesday.

As they watched Obama total 303 electoral votes to Romney's 235 for the decisive victory, there was minimal support for the newly re-elected President, a far cry from four years ago. The reason why... Kenyans have real problems of their own.

This disenfranchisement with the President so closely connected to the Kenyan paradigm is a slight surprise to students in the AUC.

"I was surprised when I heard that Kenyans did not support Barak Obama this election because they were such strong supporters in 2008," Clarence Christian, a sophomore from Pauldin, Ga. here at Morehouse said.

Indeed, the support of Obama's father's native land was a huge subplot in the 2008 Presidential election. However, those aware of the country and its political struggles in the past four years are not surprised at all by the disenfranchisement.

"Kenya's own elections in 2007 and 2008 erupted into bloody, inter-ethnic riots around the country that left more than 1,2000 dead, thousands more wounded, and an estimated 600,00 displaced," according to the Pulitzer Center.

Four years later, and the effects of the political violence that ensued during one of the country's toughest stretches are still being felt.

"An estimated 400 people have already been killed in ethnic clashes this year," Samuel Loewenberg of the Pulitzer Center said. "The clashes have been localized, and appear to be driven by a hunger for political control over natural resources," he added.

The struggles for power and money make citizens of the African country nervous in anticipation of the 2013 elections in March.

According to reports this summer was a very violent and bloody one that included 116 people that were shot and burned to death. Afterwards their bodies were dumped in mass graves near the Tana River region. The violence is only expected to increase as elections draw nearer, a somber thought for onlookers.

However, to Kenyans there is no real surprise by the events of the past four years.

"Violence as a political tool is something that has been used in Kenya," John Githongo, the former Kenyan government anti-corruption czar official said. "We have a rich history of using it strategically, internally."

Recent attempts to increase democracy and redraw boundary lines harden, and add to the ethnic tension in Kenya. This begs the question, what can be done to alleviate it?

"There are some signs of hope," Githongo said. Currently, two thirds of Kenyans have expressed faith in the equality of the judiciary system, according to a Gallup poll. Additionally, Uhuru Kenyatta and William Ruto, two presidential candidates in 2008, are facing prosecution by the ICC for their supposed roles in catalyzing efforts.

It is the hope that these efforts will manifest in peace for the prominent African country.

Trending Degree #6: Master's in Business Administration (MBA)





T.E. Lawrence, a British Army officer, once said "All men dream, but not equally. Those who dream by night in the dusty recesses of their minds, wake in the day to find that it was vanity: but the dreamers of the day are dangerous men, for they may act on their dreams with open eyes, to make them possible," and this belief drives the five people who have cultivated time and created an organization called Edge.

"[Edge stands for] educating dreamers to gain efficacy," Junior and finance chair of Edge Francisco Nunez said. "Our goal is to cultivate leaders and instill the key foundational principles that is key to their success."

Nunez, Malcolm Young, David Connor, Jessica Robinson, and Notorious Scott founded Edge last school year after going through a year of leadership and personal development, which changed their mentality of people from a negative focus to a more positive focus and outlook.

"We started our journey last year around homecoming," Robinson said, a junior and secretary of Edge. "We had to become desensitized to the social mirror to extricate ourselves from that socially driven mentality. We focused on 9 key principles that the organization is built upon, which are the key principles of leadership."

The 9 key principles are based on the book, the Slight Edge by Jeff Olson, which outlines the difference between a successful and unsuccessful person linked with their daily habits. The principles include environment, health, networking, self-image, inner circle, spirituality, social consciousness, leadership, and finance. Each meeting the Edge has as an organization is based on cultivating one of these key principles.

"So many meetings and groups discuss the problems that may be plaguing people, but in Edge we equip you with what you need to succeed and then help you with apply those things immediately to your life

through our workshop like meetings," Robinson said. "Eventually we want to create other small groups of like-minded people, not necessarily add people to our core group of people. We see the passion of the people in Edge and let the bond between people happen organically."

The idea behind creating Edge on the campuses of Morehouse and Spelman was 'divinely created'. A few years ago, Malcolm Young saw a quote on Facebook from the author of Rich Dad, Poor Dad, Robert Kiyosaki, and commented on the post saying he needed a mentor and from there he received a mentor who exposed him to book the Slight Edge.

"Malcolm shared his enlightenment with David and Francisco who were his roommates, and the rest just happened organically," Robinson said. "He used something we call the Iron Man effect. He spoke vision to his friends."

The Iron Man Effect as Robinson and Nunez went on to explain is where a person conquers the fear of networking and speaks vision to anyone willing to listen.

"Edge is referred to as a tool by our mentor," Nunez said. "Edge [and the Iron Man Effect] is a method for attracting a lot of people. The 20% that are the most receptive of the vision we portray, we infuse them with love."


On campus Edge is partnering with community organizations. They are currently working on an initiative with Greening Youth Foundation, partnering with them to mentor and tutor elementary school students. Edge also holds fundraising events including a carwash that was held last month to help raise funds for Free Enterprise Day which was held in Irvine, California.

"In California we discussed leadership, entrepreneurship, and we talked about our visions of life," Nunez said. "We talked about input and experience. It was important for us to go to this, because in the national movement, Project 1 million, there are few black people involved."

As the semester winds down, Edge is trying to raise awareness around the campuses with YouTube and Facebook videos talking about key qualities of leadership, and the creation of shirts with their Edge logo on it.

"Our goal is just to share this knowledge with other people and let them cultivate their true leadership potential," Robinson said. "Its not an easy process, and may take a long time to truly understand what everything means, but since I made the choice to take advantage of my time I have seen the vital importance of every minute in the day. I have grown from the constructive criticism I have received from the other people in edge, and most notably I have grown in every aspect of my life."

Edge recommends everyone read the Slight Edge by Jeff Olson.

Christian: Are there any special achievements you made in your life that you would like to make mention of?

Tony: The achievement that I hold most dear is attending and graduating from Morehouse College in 2006. While on campus I did a number of things in which I am very proud of: Freshmen Class President, Sophomore Class President, Treasurer of Student Government Association and Polemarch of Kappa Alpha Psi Fraternity, Inc. Pi Chapter.

In my professional life I am proud to say that I actively represent victims of domestic violence with the Atlanta Volunteer Lawyers Foundation's Domestic Violence Project. I also mentor students at B.E.S.T. Academy with the Emerging 100 of the 100 Black Men of Atlanta. Christian: What do you do on a day-to-day basis as an attorney?

Tony: Because I am a litigator, each and every day of my work varies extremely. On certain days I will be in court at depositions or hearings, other days I may be drafting briefs, but everything I do is geared towards minimizing my client's exposure of risk in all facets of litigation.

Christian: What obstacles did you have to overcome to become an attorney?

Tony: Well of course the obvious obstacle of taking the LSAT, which was not an easy feat. Another being attending one of the top law schools in the country, University of Michigan Law, and sitting side by side with students that came from schools like Harvard, Yale and Stanford and ensuring that I did represent Morehouse in a positive light.

Also being competitive with my peers at this institution, finishing the bar exam and of course just the day to day learning that takes place as a young lawyer were obstacles I had to overcome.

Christian: How important is an LSAT score for those wanting to attend law school?

Tony: At most law schools the LSAT is a required exam. It's very important because the score on your LSAT coupled with your GPA largely determine what caliber of intuitions you will be able to attend.

We all know the better the school the better the job prospects coming out. To avail yourself with the most options and opportunities, it's vital to perform very very well on the exam.

their publications and material helped me tremendously in preparing for the LSAT as well as supplementary material such as those by Kaplan and Princeton Review. All of the Power Score publications go into great detail and can make it easy for someone divorced from Standardized testing or someone who is a senior in college who hasn't taken standardized testing since the SAT.

Christian: Would you recommend students to go to the best law school they can or would you say go to the best law school that's right for you?

Tony: At the end of the day I don't believe that there is a such thing as the right law school for you . There is no secret that law school doesn't equip you to be an actual lawyer. Most of the learning you do about lawyering takes place in the first several years of your career.

To attain a law degree you can go anywhere but to maximize your options consider the ranking of the school and also the region that you intend to practice. It is also very important to consider the cost of a legal education because it is no secret that law school is very expensive and the cost varies among institutions.

As we all saw in 2008-2009 the economy collapsed. Several people walked out with out severance pay, and they have huge debt loans without any way to pay them due to circumstances that were beyond their control. Scholarships and other means of financial aid that don't have to do with loans is something to consider.

Christian: So what other suggestions do you have to Morehouse students looking to become attorneys?

Tony: Talk to other attorneys and if possible shadow someone. As far as college is concerned definitely have

Math. It would appear that Paul Ryan's favorite word is exactly the reason he and Governor Romney were soundly defeated a week ago. From the outset, a tremendous Democratic electoral advantage, amongst other things, essentially doomed the hapless Romney campaign. Among the non-swing states, Washington D.C. and the 22 solidly "blue" states (i.e. California, New York, Massachusetts, New Jersey, Washington, etc.) altogether command 253 electoral votes, compared to the 206 electoral votes of the 25 solidly "red" states. This nearly overwhelming 47-vote difference, gave President Obama a much larger base and a much easier stroll to a 270 electoral vote victory. Ultimately, things just didn't add up for the Governor and his "numbers guy."

Governor Romney would have had to win Florida or Ohio to have any real chance at winning the presidency, whereas President Obama could have lost both states and still have won. The day before the election, the New York Times calculated 431 paths to the White House for Obama and a mere 76 for Romney, all of which included his winning Florida, Ohio, or both. The underlying causes of Governor Romney's and his party's massive defeat, however, are even more telling.

A "time bomb" exploded on Tuesday and utterly shattered any Republican's chances of retaking the White House or the Senate, weakening their majority in the House of Representatives, and further weakening their majorities in several state legislatures. President Obama and

Democrats across the country surged to victory on the votes of a broad coalition of Americans. The president alone earned 94 percent of the African-American vote, 71 percent of the Hispanic vote, and 73 percent of the Asian-American vote. 57 percent of women voted for Obama, as well as 60 percent of young Americans between the ages of 18 and 29.


It would appear that Republicans could no longer depend on a majority of white voters to put them over the top. Democrats have amassed a formidable electoral advantage with the support of an overwhelming majority of minority, young, and women voters. That the Democratic Party is the actual "big tent" party would have been abundantly clear to anyone who noticed the difference between the crowds at the conventions or at Obama and Romney campaign rallies.

The sea of older white faces at the Republican National Convention mirrored those at Romney rallies throughout his campaign. Alternately, the crowds at the Democratic National Convention and Obama rallies were younger and much more colorful.

This demographic arrangement is the same in congress. When the 113th congress convenes in January, women and minorities will make up a majority of the Democratic caucus while the Republican caucus will remain 90 percent white, and male. Of the 20 women who will take seats in the Senate in January, 18 are Democrats. The demographic differences of the two parties are as stark as the differences between their platforms, and unless the Republicans find some way to attract more minority and female support they are, quite literally, doomed.

One would think that after effectively delivering the country into the hands of a blithering idiot in 2000, that the state of Florida might have done something in the intervening 12 years to avoid embarrassing itself yet again before the entire nation. Since its inception, the Halo franchise has been under the watchful eye of developer Bungie and Microsoft. After 11 years and seven games, including a side-story, spin-off, re-make and a prequel, Bungie has moved on and given the franchise over to another studio. Thankfully, 343 Industries has proven them-selves more than up to the challenge and delivered one of the best Halo games to date.

We last left Master Chief floating through space on the remnants of the Forward Unto Dawn at the end of Halo 3. Now, four years later Spartan-117 finds himself under covenant attack while orbiting an artificial Forerunner world called Requiem. At the same time, Chief's artificial companion Cortana is slowly degrading as she enters "rampancy," the end of an Al's lifespan in the Halo universe.

While the Halo storyline has always been epic in scale, the games have lacked a sense of humanity. Master Chief exists solely for the players to project themselves onto. Other than a few one-liners here or there the chief is a fairly quiet man, opting to speak with his gun rather than his mouth. Following in Halo: Reach's footsteps Halo 4 tries to bring some emotion to the franchise; with mixed results. The gruff hero has more spoken dialog than ever, but it's Cortana that steals the show. Over time, Cortana has become much more than the chief's virtual navigator thanks in no small part to Jen Taylor's fantastic voice-over work. Cortana's decent into rampancy gives the game some much needed pathos. The writing is mostly competent, though a few clunky lines can drag the experience down at times.

For those familiar with the Halo campaign experience, this go-around should be fairly easy to get into. Most of the Covenant baddies are back excluding a few of the less popular ones. New to the series are the Prometheans, a race of mys-


and Dominion. For those well versed in Halo multiplayer, prepare to be more than a little shaken. A handful of minor and a few major changes make competitive multiplayer fresh without alienating long-time fans.

Upon entering your first game of Infinity Slayer, veteran players will notice that weapons are no longer spread across the map, drastically changing the flow of normal slayer game types. Players are no longer required to memorize map layouts and rush for power weapons at the start of matches. Instead, weapons are disseminated via ordinance drops. For Call of Duty fans, this concept should seem familiar. As you gain points throughout the match, you gain the opportunity to select new weapons and powers. This allows the flow of power weapons to be tiered throughout the match. Before matches start, you can create customizable loadouts for your Spartan. Like in Reach, your loadout allows you to choose your weapons and armor abilities but now every character is also granted a tactical pack and a support upgrade. Whether these additional perks will unbalance the game has yet to be seen, but considering that these upgrades are available to all players and can be changed on the fly, it's hard to see them becoming a problem.

Replacing Reach and ODST's Firefight mode is the allnew Spartan Op modes. Loosely tied to the main campaign, Spartan Ops episodes tend to be relatively short co-op based missions that skip the details and get right to the action. Though enjoyable, the additional content is over fairly quickly even on legendary difficultly, making the decision to drop Firefight questionable. For those looking for a more narrative drive experience the main campaign is also co-op compatible. Currently there are five Spartan Op missions available on disc with the promise of more being released over time via Xbox Live.

terious Forerunner created warriors that bring a new dynamic to the Halo campaign. Attempting to fight the Prometheans like the Covenant is a quick way to get killed and should throw players for a loop during their first few encounters. Overall, the campaign is fun and satisfying for those looking for a single player experience in a first person shooter.

Multiplayer is back under the moniker of Infinity, containing War Games (Competitive Multiplayer), Forge (Map Editor), and the all-new Spartan Ops (Co-op). All the classic multiplayer modes are back in addition to a few new ones like Regicide 343 Industries took on the monumental job of creating a competent Halo game following Bungie's departure and I'm pleased to say that they have done a tremendous job. Opting to make significant changes to the series was a risk that ended up paying off big time. Still, there are lingering doubts. For all the game's triumphs, there are a small handful of small mistakes. The changes in art, writing and gameplay may become welcome additions over time, but 343 Industries' long term impact on the franchise remains to be seen. If Halo 4 is any indication of the future, the chief should be in good hands.

Marvel Comics is responsible for some of pop culture's most recognizable characters, with decades of serialized comics providing the foundation of the company's superhero universe. Under the new Marvel NOW! initiative, the lineup of superhero books will undergo an overhaul that will define its creative direction in a post-Avengers entertainment market. The decision to retool its current releases will provide new readers with a new starting point within The book starring the fourth wall-breaking mercenary is written by Brian Posehn and Gerry Duggan. Posehn is best known for his comedy work, including his role as Brian Spukowski on The Sarah Silverman Show. Deadpool is illustrated by Tony Moore, a cocreator of The Walking Dead.

Moore will no doubt be right at home during the series' first arc, which features Deadpool battling against the reanimated corpses of America's

the Marvel universe, while shaking up the current status quo for longtime fans.

Marvel NOW! can be compared to rival DC Comics's New 52 re-launch last year, which reset the long standing history of iconic characters like Batman, Superman and Wonder Woman and restarted the company's entire lineup of 52 series from issues number one. Though Marvel maintains that the initiative is not truly a re-launch, it allows the company to shuffle the creative teams working on the company's most well-known properties and will provide a relatively clean slate for the incoming writers and artists.

The landscape of the Marvel Comics universe is a much different one than what is present in the movies. While The Avengers assembled for the first time on the big-screen, Captain America led his expanded team into battle against Cyclops and his embattled X-Men in a crossover comic event. Avengers vs. X-Men served as the catalyst for Marvel NOW!, and defined the coming shift in the Marvel status quo.

Following the event, Brian Michael Bendis will end his eight year tenure as writer on the Avengers line of books, and will take his talents to the X-Men side of Marvel's publications. Similarly, writer Ed Brubaker will end a run on Captain America that began in November 2004. Marvel has has placed their faith in Venom and Punisher writer Rick Remender, who will be responsible for the re-launched Captain America, and a new series titled Uncanny Avengers, which will feature an Avengers team with both original Avengers and members of the X-Men.

One of the first series to re-launch under the Marvel NOW! imprint was fan favorite Deadpool.

One of the more controversial decisions coming out of Marvel NOW! is the conclusion of The Amazing Spider-Man at issue 700 this December. Replacing the book will be The Superior Spider-Man, a new series featuring a Spider-Man that is not Peter Parker. Author Dan Slott took over as the series' sole writer in January 2011, and was the only writer to survive the Marvel NOW! creative shuffle among the company's flagship titles. The identity of the new "superior" Spider-Man will remain a secret until its January release, prompting an outcry from fans fearing that Peter Parker may not survive his 50th anniversary year.

Along with decades of serialization comes the constant re-interpretation of characters by different creative teams as they come and go. While writers like Brubeck and Bendis have spent the better part of a decade on some of their books, others last less than a year. Marvel NOW! will allow the company to place ideal creative teams on each of its new series, with an emphasis on longevity, making it more than just a marketing strategy.

Books under the Marvel NOW! imprint will continue to launch throughout the winter, including titles like All-New X-Men, Iron Man, Savage Wolverine, Guardians of the Galaxy, Thunderbolts and more.
